### **MINI BULL CRITERIA**

A Mini Bull must be of a miniature breed measuring no more than 122cm from hoof to hip must be at least two (2) teeth.

#### **COMPLAINT PROCESS**

- A bull may have 3 complaints in a season
- Complaints must be submitted in writing to either the Rodeo MRC or Junior Roughstock Director.

### MINI BULL CONTRACTORS

- Must have completed the application procedure and await relevant approval
- Only ABCRA approved Mini Bull contractors can supply stock for Mini Bull events
- The Board reserve the right to ban any stock they deem as unsuitable
- Stock must meet the criteria guidelines to be approved
- Open contractors that wish to buck mini bulls must be ABCRA approved Mini Bull Contractors and have their Mini Bull stock approved or;
- Open contractors may buck their stock under an ABCRA approved Mini Bull Contractor providing the Mini Bull stock has been approved.
- Mini Bulls that HAVE NOT BEEN APPROVED shall NOT be used under any circumstance
- All other ABCRA rules and conditions including Animal Welfare standards must be strictly adhered to.

#### PENALTY

Any contractor that uses a Mini Bull before that head of stock is approved, shall be immediately disqualified as an ABCRA Approved Mini Bull Contractor.



### **MINI BULLS CRITERIA**

### MINI BULL RULES

### 1. Mini Bull Stock

- a. Bulls to be used in a Mini Bull event will be restricted to suitable stock.
- b. Mini Bulls will comply with miniature breed guideline of 122cm measured from hoof to the hip at full maturity.
- c. Stock used must be ABCRA approved as suitable.
- d. All stock must have been handled and tried out before being used at an event.
- e. All stock must be supplied by an approved ABCRA Mini Bull Stock contractor.
- f. the Board reserves the right to ban any stock they deem as unsuitable.

### 2. Mini Bull Event

- a. Mini Bull Ride will be conducted in two age groups 8 to Under 11 and 11 to Under 14
- b. Conducted as a one-handed event
- c. Qualifying time of six (6) seconds.
- d. All stock must be flanked
- e. Mini Bull events are a stand-alone point event.
- f. Points will be awarded as follows:

1 <sup>st</sup> Place	5 points	
2 <sup>nd</sup> Place	4 Points	
3 <sup>rd</sup> Place 3 Points		
4 <sup>th</sup> Place 2 Points		
5 <sup>th</sup> Place 1 Point

- g. Trophy levies apply to entry for end of year awards.
- h. In the effort to recognise all levels of competitors and continue Junior development; a 'Most Improved' rider in each age group at each Show will be nominated. Points will accumulate for a Most Improved award at the end of year presentation.
- i. Point score will commence from 1 December 2020.
